WEBSITE PRIVACY POLICY

This Privacy Policy applies to the services offered by Lee Brothers Fencing Group

1. Personal information:

The Lee Brothers Fencing Group is committed to safeguarding personal privacy. It recognises that individuals have a right to control how their personal information is collected and used. Providing personal information is an act of trust and it is taken seriously. Unless given consent to do otherwise, Lee Brothers will only collect and use personal information as set out below.

2. Collecting personal information:

Lee Brothers will not collect or monitor any personal information about an individual without their consent. The only personal information collected is what has been provided voluntarily.

3. Use of tracking technologies:

Lee Brothers uses tracking technologies such as cookies or web beacons to make use of the website and services as convenient as possible. Cookies are pieces of information that a web site transfers to a computer's hard disk for record keeping purposes. Most web browsers are set to accept tracking technologies such as cookies or web beacons. These tracking technologies do not themselves personally identify users, although they do identify a user's browser.

4. Using and disclosing your personal information:

- To fulfil obligations under any sale and purchase contract and/or any other contract between the individual and Lee Brothers.
- To render services related to Lee Brothers' business such as warranty or after sales services.

For the purpose described above, information may be shared with Lee Brothers Fencing Group companies either in Australia or overseas. Also, in order to operate the web site or deliver a service, personal information may also be shared with a service provider, a non-Company group company.
